1. Call to Order and Roll Call:

- a. Members Present: Karla Jones, Chairperson, Isabella Bender, Vice Chairperson, William Bender, Donnetta Skinner, Jan Brizee
- b. Members Absent: Member Khatlyn Micheli, Vice Mayor Lincoln Litchfield
- c. Staff Present: Melinda Harris, City Clerk
- d. Public Present: Mike Tangreen and McKenna Hines from NewGen Farms.
- 2. Public Comment This time is devoted to comments by the general public and discussion to those comments. No action may be taken upon a matter raised at this time until the matter has been included on a successive agenda and identified as an action item. Pursuant to NRS 241.020. (Non-Action Item)
 - a. McKenna Hines stated that NewGen Farms had gone in front of the Carlin City Council to get approval to move their dispensary license from Eureka County to Elko County and it did get approved. Mike Tangreen stated that he has talked to the Chief of Police, the Fire Chief, and the City Manager. State requirements are that it needs to be 1000 feet away from school and 300 feet from a community facility or park. They would be locating their dispensary at 402 Highway 278. The dispensary would be its own building on the same property as the Dovetail which is zoned Restricted Commercial. Will need to get on a future agenda for zoning.
 - b. Chairperson Karla Jones stated that she wanted to bring back the proposed draft of Title 3 to review zoning for marijuana dispensaries. The Council has already approved it, so we need to find a zone for it.
- 3. Pursuant to 3-11-6 of the Carlin City Code: review, discussion and possible approval of the election of a Chairperson and a Vice Chairperson for the 2019-2020 fiscal year and all related matters. (For Possible Action)
 - a. Member Donnetta Skinner stated that she wanted to keep the same people.
 - b. Member Donnetta Skinner made a Motion to appoint Karla Jones as Chairperson and Isabella Bender as Vice Chairperson and all related matters. Member Jan Brizee seconded the Motion. Motion passed.

- a. Chairperson Karla Jones read Anna Claudine Meierhoff's letter into the record. "I Anna Claudine Meierhoff have moved back to Carlin recently and am interested in being on the Carlin Planning Board. I served on it many many years ago and enjoyed it. I, now once again, am interested. Thank you for your time."
- b. Chairperson Karla Jones stated she had no issues. The Planning Board would be full and we need a variety of input.
- c. Member Jan Brizee made a Motion to approve to appoint Anna Claudine Meierhoff to the Planning Board. Isabella Bender seconded the Motion. Motion passed.

 - b. Chairperson Karla Jones stated that the lawyers may have a problem with spot zoning, but that if they are redoing that entire block, that the lawyers may not have an issue with it. It is a residence on a commercial zoned property. When we pass Title 3, it would clean this whole block up.
 - c. Member Isabella Bender made a motion to close the public hearing. Donnetta Skinner seconded the Motion. The Motion passed.

Member Jan Brizee made a Motion to approve the Master Plan Survey to be sent out by August 31st, with an indication on the survey that the respondents need to submit those by September 30th, with data analysis in October, and data back to the Board on the November agenda and all related matters.
